Final payment before departure must be received on or before **February 28, 2023**. If the final payment is not received by **February 28, 2023**, the reservation is subject to cancellation, and payments and/or deposits will not be refunded.

Cancellation before the departure date after payment will be subjected to the following:

On and after **March 15, 2023**, the traveler and/or customer will lose the non-refundable booking fees and 100% of all payments.

On and after **February 15, 2023**, the traveler and/or customer will lose the non-refundable booking fees, and 50% of all payments received.

On and after **January 15, 2023**, the traveler and/or customer will lose the non-refundable deposit.

Any cancellations must be in writing.

Suppose you are traveling with a companion or fellow traveler; in the case of his/her cancellation, you will be subjected to any additional fees and/or costs accordantly to the terms and conditions of the hotel and services.
